DESCRIPTION OR NATURE, PURPOSE, AND BENEFICIARIES OF THE PROJECT:

The proposed Project will remodel the existing outdoor playground area by replacing the existing playground equipment and shade structure at the Zev Yaroslavsky Family Support Center. The Center is a multi-program LA County facility that provides various support services for LA County residents in one convenient location. The Center has an outdoor playground that is partially covered by an existing shade structure. The existing shade structure does not provide adequate and consistent shade over the playground resulting in some of the playground equipment being exposed to direct sunlight for extended periods of time. The playground equipment and the rubber mats have deteriorated over time. This presents a potentially unsafe condition for children that are playing on the playground equipment during their visit to the Center.

REASONS WHY PROJECT IS EXEMPT:

The scope of work consists of the replacement of existing playground equipment. Therefore, the work is within certain classes of projects that have been determined not to have a significant effect on the environment because it includes repairs and minor alterations to existing public facilities with negligible or no expansion of use, replacement of features with the same purpose and capacity, placement of small equipment and accessory structures, and installation of equipment at existing facilities.

In addition, based on the records of the proposed Project, it will comply with all applicable regulations, it is not in a sensitive environment and there are no cumulative impacts, unusual circumstances, damage to scenic highways, listing on hazardous waste site lists compiled pursuant to Government Code section 65962.5, or indications that it may cause a substantial adverse change in the significance of a historic resource that would make the exemptions inapplicable.
